The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Non-compliance with requirements under the *Long-Term Care Homes Act, 2007* (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

WN #1: The Licensee has failed to comply with LTCHA 2007, c.8. s.6 (10) (c)

(10)(c) The licensee shall ensure that the resident is reassessed and the plan of care reviewed and revised at least every six months and at any other time when c) care set out in the plan has not been effective.

#### Findings:

#### Staff did not reassess or revise the plan of care after a new skin issue was identified.

- 1. October 2010, Staff documented in progress note that a resident's buttock area was excoriated & painful to touch. Staff provided treatment once as nursing intervention. No other evidence of reassessment or treatment was provided until 23 days later when a Personal Support Worker (PSW) reported on the resident's buttock open area.
- 2. The resident's plan of care was not revised to address his new skin issue after it was identified in Oct and Nov, 2010. Care plan strategies remained the same as of the home's latest review in Sept, 2010.

November, 2010 the physician saw the resident and prescribed treatment to the buttock open area. The buttock open area closed after 17 days.

### **Additional Required Actions:**

**VPC** - pursuant to the *Long-Term Care Homes Act, 2007*, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance with ensuring staff re-assess and revise care plan strategies when care set out in the plan has not been effective.
