The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): November 19, 20, 27, 28, 29, 30, 2018, December 3, 4, 2018

Intake Log #018489-18/ CIS #2834-000003-18 - related to a resident fall, hospital transfer and significant change in condition.

Intake Log #016624-18/ CIS #2834-000014-18 - incident with injury, hospital transfer and significant change in condition.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care (DOC), The Assistant Director of Care (ADOC), the Environmental Services/Maintenance Manager (ESM), Registered Nurses (RN), Registered Practical Nurses (RPN), Personal Support Workers (PSW), a housekeeper and residents.

During the course of the inspection, the inspector reviewed the critical incident system reports (CIS), the licensee's investigation documentation, an equipment manual and service agreement, ceiling lift inspections, health records, the licensee's policies and procedures specific to Preventative Maintenance, Zero Tolerance of Abuse and Neglect of Residents # AM-6.9, Managing Responsive Behaviours #SM-1.4, MDS Significant Change in Status Assessment and Timelines # RAI-21.5, Neurological Assessment Post Head Injury # CS-12.2, and observed resident care and services.
