Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Critical Incident inspection.

During the course of the inspection, the inspector(s) spoke with the home's Administrator, Director of Care, several Registered Nurses, a Registered Practical Nurse, several Personal Support Workers, a Life Enrichment Aid, as well as to several residents.

During the course of the inspection, the inspector(s) reviewed several residents' health care records, observed resident care and services, reviewed two critical incident reports, reviewed the home's Abuse/Neglect of Residents by Staff policy # HR-RA-2.2 and Respect Always policy # HR-RA-1.1, both revised in August 2011.

It is noted that two critical incident inspection logs # O-002124-12 and #O-002196-12 were conducted during this inspection.
