**The purpose of this inspection was to conduct a Complaint inspection.**

**This inspection was conducted on the following date(s): July 4, 7, 8, 9, 2014.**

**During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Assistant Director of Care (ADOC), Behavioural Supports Ontario (BSO) staff, Geriatric Psychiatry Outreach Team Nurse, Medigas Home Service Representative, Registered Practical Nurses (RPN), Personal Support Workers (PSW), a Registered Nurse (RN), a Life Enrichment Aide (LEA), and a Substitute Decision Maker (SDM).**
