Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Complaint inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care, Registered Practical Nurse, Day Program Staff and the Senior Support Officer.

This inspection is related to log number H-000097-12

During the course of the inspection, the inspector(s) reviewed the residents clinical record and conducted interviews with staff.

Two full-time, front line, staff who were responsible for the care of the resident were interviewed as part of this inspection. These interviews included discussions regarding: the residents cognitive status, care and services provided, known behaviours and triggers for the identified resident, as well as determined staff knowledge of the homes abuse policy.

A telephone interview was conducted with the Senior Support Officer, which included reviewing an audio recording of a resident interview conducted in 2012.
