The appropriate placement co-ordinator shall give the licensee of each selected home copies of the assessments and information that were required to have been taken into account, under subsection 43 (6), and the licensee shall review the assessments and information and shall approve the applicant's admission to the home unless,

- (a) the home lacks the physical facilities necessary to meet the applicant's care requirements;
- (b) the staff of the home lack the nursing expertise necessary to meet the applicant's care



requirements;

Findings:

1. Discussed with the Administrator that resident a resident application refusal did not met the requirements for refusal under LTCHA, 2007, S.O.2007 c.8, s.44(7)(a)(b). The client was not approved as she required assistance with transfers.
2. The home denied application refusals for eleven clients from August 23-October 13, 2010.
3. The grounds for application refusal included, two residents who smoked, one resident with G tube, six residents who required assistance with transferring including staff and mechanical transfers, one resident who resident lacked motivation and one resident who was independent.
4. A review of four client applications indicated that the home did not request any additional information from CCAC prior to refusing the applicants admission to the home.
