The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): January 14, 15, and 16, 2015

During the course of the inspection, the inspector(s) spoke with Director of Care (DOC), Assistant Director of Care (ADOC), registered staff including Registered Nurses (RNs) and Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), Physiotherapist, and family.

Inspector also observed the provision of care, reviewed health records, investigation report, relevant policies and procedures and interviewed staff.

The following Inspection Protocols were used during this inspection: Continence Care and Bowel Management Pain Personal Support Services Reporting and Complaints Skin and Wound Care

Findings/Faits saillants :

1. The licensee has failed to ensure that the care set out in the plan of care was provided to the resident as specified in the plan.

A) Resident #001 had a pathological fracture in 2014. The plan of care that was in place prior to the fracture and after was reviewed. A number of staff members that provided direct care to the resident were interviewed during the inspection. The interviews indicated that not all staff followed the resident's plan of care before the resident's injury. The plan of care for resident #001 before the injury indicated that the resident "required two person total assistance for showers twice weekly and two person total assistance for dressing". Staff members interviewed identified not all showers provided to the resident were with two person assistance. One staff member stated that the resident did not require a two person total assistance for showers before the injury. Other staff members indicated that personal hygiene and dressing was also provided by one staff member. The care set out in the plan of care was not provided to the resident as specified in the plan.

B) Resident #002's plan of care was reviewed and indicated that the resident was "totally dependent on 2 staff for dressing and required 2 staff assist for personal hygiene and oral care". A staff member that provided direct care to the resident was interviewed and reported that personal hygiene, dressing and oral care was provided by one staff member and only transfer was done with two staff members. The staff did not provide care as specified in the plan of care.

C) Resident #003's plan of care was reviewed and indicated that the resident required "2 staff total assistance for grooming and personal hygiene daily and PRN". A staff member that provided direct care to the resident reported that personal hygiene was provided independently and only transfer was done with 2 staff members. The staff did not provide care as specified in the plan of care. [s. 6. (7)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the care set out in the plan of care is provided to the resident as specified in the plan., to be implemented voluntarily.
