The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): May 12 and 13, 2016.

This follow up log #007414-16 inspection was related to inspection #2016_270531_0001 compliance order #001, the licensee had failed to protect a resident from abuse by anyone, LTCHA, 2007, s.19 (1) was issued on February 18, 2016 with a compliance date of April 10, 2016.

During the course of the inspection, the inspector(s) spoke with the Administrator, Registered Nurse (RN), Registered Practical Nurse (RPN), Personal Support Workers (PSW), Activity Aide and the Cook.

Also completed during the inspection included a tour of a resident care area, observed interaction between staff and residents. Reviewed minutes from a general staff meeting and a family council meeting, the licensee's Long Term Care Home Plan of Corrective Action, policies, and education programs including staff attendance related to zero tolerance for resident abuse and neglect.
