Complaint Logs #019997-18, related to personal care and documentation, log #002556-18, related to allegations of resident to resident physical abuse, log 029487-18, related to personal care and management of nutrition and hydration, log #029844-18 related to communication response and log #031410-18, related to an allegation of staff to resident sexual abuse were inspected concurrently during this inspection.

During the course of the inspection, the inspector(s) spoke with the Director of Care, Registered Dietitian, Residents, Substitute Decision Makers, Registered Nurse, Registered Practical Nurses, Personal Support Workers, Activity Aide, Food Service Manager and RAI Coordinators.

During the course of this inspection, the inspectors reviewed residents' clinical health records, the licensee's 2017 and 2018 complaint logs. Observed a resident meal service related to complaint log 029487-18 and observed staff to resident interactions during the provision of care.
