**The purpose of this inspection was to conduct a Follow up inspection.**

**This inspection was conducted on the following date(s): December 17, 2015**

**An inspection (2012-168202-0030) was previously conducted on December 19, 2012 and an Order #001 was issued on January 3, 2013 for non-compliance regarding insufficient lighting levels specifically in resident rooms and corridors. During a follow-up inspection (2014-189120-0062) conducted on September 24, 2014, the lighting levels were confirmed to be adequate in resident bedrooms and corridors and the Order was closed. However, during this inspection, the minimum required levels in common areas, resident ensuite washrooms and shower rooms were not met. A new Order was issued on October 9, 2014 for compliance by September 30, 2015. For this follow-up inspection, the conditions that were laid out in the Order have been met.**

**During the course of the inspection, the inspector(s) spoke with acting Administrator and Environmental Services Supervisor.**

**During the course of the inspection, the inspector toured each of the five home areas and measured illumination levels in random common areas (television room, family room, activity room) in each home area, three dining rooms, two shower rooms and two resident ensuite washrooms. The licensee either added or replaced light fixtures and/or replaced bulbs to increase the illumination levels to above minimum required levels.**
