The purpose of this inspection was to conduct a Complaint inspection.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Environmental Services Director, several registered and non registered nursing staff, laundry staff.

During the course of the inspection, the inspector(s) reviewed policies and procedures related to laundry services; toured the laundry room; checked the lost and found items storage area; audited the contents of several residents' clothes closets; toured the 4th floor of the home. During the inspection on the 4th floor, it was observed that point of care hand hygiene agents are not provided in many residents' rooms. This issue is not related to the complaint inspection issues.

**WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 229. Infection prevention and control program Specifically failed to comply with the following subsections:**

**s. 229. (9) The licensee shall ensure that there is in place a hand hygiene program in accordance with evidence-based practices and, if there are none, in accordance with prevailing practices, and with access to point-of-care hand hygiene agents. O. Reg. 79/10, s. 229 (9).**

**Findings/Faits sayants :**

1. Point of care hand hygiene agents are not provided for use in the majority of 4th floor residents' bedrooms.
2. Staff do not carry hand hygiene agents into residents' bedrooms other than when nursing staff enter bedrooms with care carts or care caddies that contain bottles of hand hygiene agents.
